B. SCOPE OF WORK

1. OVERVIEW: The US Embassy Djibouti has a requirement to repair all cracked surfaces and repaint for both perimeter wall and fences. The works shall be done as per scope of work, specifications, and general contract conditions. This project requires an experienced contractor to execute the job.

2. PROJECT DESCRIPTION

- 2.1. The summary of this SOW includes repair work and repainting for:
- 2.2. Compound perimeter concrete plaster finish wall
- 2.3. Demark rooms, receiving room, trash-room exterior walls
- 2.4.MCAC, SCAC, CCAC exterior concrete plaster finish surfaces including exterior porch ceiling
- 2.5. Sally-port metal grill fence, slide gates and frames
- 2.6. Metal grilled fences at the perimeter
- 2.7. Metal grilled fence: CCAC to Consular waiting room privacy fence.
- 2.8. Swimming pool metal grill fence and Playground metal grill fence
- 2.9.Bollards: Chancery building front yard, MCAC front yard, CCAC, and sally ports.

3. PRIOR TO IMPLEMENTATION

- 3.1. Submit to the CO and/or COR within 15 days of Notice to Proceed, document submittal package that includes:
- 3.2.Bill of material to be ordered by contractor with estimated delivery times and dates,
- 3.3. Complete finalized Execution Plan including Critical Path Method (CPM) schedule
- 3.4. Accident prevention plan (APP).
- 3.5.All Submittals for COR approval. Provide product data, shop drawings, samples, and test results to the COR.

 - 5.2.3. Bollards: 95 pcs
 - 5.2.4. Swimming pool: 250 Sq. Meters
 - 5.2.5. Playground: 250 Sq. Meters

- 6.2. Finish Coats:
 - 6.2.1. Steel Substrates: Polyurethane, Pigmented, Epoxy Zinc Rich Primer and High-Build Epoxy Coating System: MPI EXT 5.1G.
 - 6.2.2. Prime Coat: Epoxy Zinc Rich Primer MPI #20
 - 6.2.3. Intermediate Coat: High-performance, Polyamide-epoxy coating, High-Build Epoxy Marine Coating, Low Gloss: MPI#108
 - 6.2.4. Topcoat: Polyurethane, two-Component, Pigmented, Gloss: MPI#72
 - 6.2.5. Stucco Substrates; Latex System, MPI EXT9.1A
 - 6.2.6. Prime Coat: Factory-formulated acrylic-latex for exterior application; VOC < 200 g/L
 - 6.2.7. Intermediate Coat and Topcoat: Factory-formulated semi-gloss waterborne acrylic-latex enamel for exterior application; MPI#15 Exterior Latex, Low Sheen, MPI Gloss Level 3-4, VOC Content Range-E3.
- 6.3. System manufacturer's factory mixed formulation of acrylic polymer, aggregate, and color -fast pigments producing finish resistant to dirt pick-up.
- 6.4. Colors standard based on Benjamin Moore HC-92, "Wheeling Neutral" or equal
- 6.5.Use single color batches for individual colors to avoid color changes from differently mixed batches.
- 6.6. Water: suitable for domestic consumption, free of harmful soluble salts, acids, alkalis and other deleterious matter which would impair the work.

7. CONTRACTOR PROVIDED MATERIALS

- 7.1. All necessary materials including paint, prime, thinner, joint sealant, cement, aggregate, sand etc.
- 7.2. Tools and safety gear
- 7.3. Equipment: pressure washer, lifter, scaffolding, and all other equipment required for the project
- 7.4. Potable grade water required for cleaning and paint mixing.
- 7.5. Portable generator with fuel for required electric demand
- 7.6.All logistics including storage space, site office, first aid facility, portable toilets etc.:
- 7.7. The material submittals shall be approved by the COR in advance.

8. EXECUTION:

8.1. **GENERAL**

- 8.1.1. Mask/protect areas where plaster removal and paint stripping is not desired, including adjoining surfaces where overspray may travel. Polyethylene (plastic sheets) and masking tape create an effective barrier. Plants and other foliage should be covered or rinsed thoroughly before and during application.
- 8.1.2. Do not stockpile debris. Promptly dispose of obsolete equipment and debris at locally authorized disposal sites each day.
- 8.1.3. Fire extinguishers shall be kept on-site at all times during repair operations.
- 8.1.4. Mask-off equipment to remain.

8.2. PREPARATION OF SUBSTRATE

- 8.2.1. All areas of the existing surfaces shall be thoroughly prepared to receive a new paint system. Surface preparation is the most critical procedural requirement.
- 8.2.2. Inspect the existing condition of the painted exterior walls surfaces and metal components to determine the areas, which require special cleaning to remove excessive loose plaster, stains, flaked paint, rust, scratches and cracks. walls require high pressure washing to be applied before repainting.
- 8.2.3. Contractor shall determine the condition of the existing substrate. All defects in the substrate shall be corrected before painting work commences. Areas of deteriorated substrate, porous or other affected materials must be removed and replaced with new to match existing.

- 8.2.4. Remove all loose stucco plaster particles, delaminated paint, efflorescence, mold, mildew and other foreign materials. Areas shall be first sounded, scraped, swept clean, and then thoroughly power washed.
- 8.2.5. Remove softened/lifted paint using a scraper. Agitate tough to remove residue with a stiff nylon brush or scouring pad, paying particular attention to cracks, crevices and grooves.
- 8.2.6. Remove corroded metal control/reveal joints and corner beads. Saw-cut end sections to prepare for new metal repair sections.
- 8.2.7. Remove loose paint, where the plaster is peeled off from the substrate, remove plaster down to stable state or concrete substrate. Cut "V" shaped incisions following hairline plaster cracks.
- 8.2.8. Rake out joints to depths equal to 2-1/2 times their widths, but not less than 25 mm (1inch), nor less than that required to expose sound, weathered plaster. Route out cracks to a depth of a minimum of 6 mm by 6 mm (1/4-inch by 1/4-inch).

8.3. POWER WASHING

- 8.3.1. The stripped surface must be thoroughly rinsed with clean water. Exterior surfaces should be rinsed with a power washer.
- 8.3.2. Spray Equipment: Use high power adjustable pressure washer with a minimum 3500 PSI (Pounds per Square Inch) mechanical spray device. Use spray equipment that provides controlled application at volume and pressure measured at nozzle. Adjust pressure and volume to ensure that cleaning methods do not damage surfaces, including joints.
- 8.3.3. Perform each cleaning method in a manner that results in uniform coverage of all surfaces, including corners, moldings, and interstices, and that produces an even effect without streaking or damaging surfaces. Keep wall wet below area being cleaned to prevent streaking from runoff.

8.4. PLASTER REPAIR

- 8.4.1. Repair cracks, holes and surface defects on stucco plaster walls surfaces. Patch, plaster and restore damaged wall's areas and prepare surfaces for painting. Repaired areas shall be blended to surrounding areas.
- 8.4.2. Control/Reveal Joints and Corner Bead Repair: Attach metal flanges with expanded mesh directly to the concrete substructure, butt ends to existing sections and fasten at 200mm on center and minimum 25mm from end of metal.
- 8.4.3. Prepare surfaces by water misting existing plaster and substrates adjacent to repair area. Sequence plaster application with the installation and protection of other work so that neither will be damaged by the installation of the other.

- 8.4.4. Completely fill panel area between control joints to receive new plaster with material in a minimum of two lifts. Ensure all voids and entrapped air are eliminated.
- 8.4.5. Apply finish coat of plaster over repair materials to provide finished appearance to match existing. To ensure that the repaired area blends into the surrounding surface, provide sufficient crest over the opening to allow for shrinkage. The patch shall be feathered to zero at the edges using a brush, knife, or trowel.
- 8.4.6. Tolerances: Do not deviate more than 3mm (1/8-inch) in 3M (10 feet) from a true plane in finished plaster surfaces, as measured by a 3M (10 foot) straightedge placed at any location on surface.
- 8.4.7. Cure repaired and existing plaster surfaces by spray misting for three consecutive days. Allow plaster surfaces to dry thoroughly before painting.

8.5. JOINT SEALANT REPAIR

- 8.5.1. During repainting work, existing conditions maybe encountered which are not known or are unforeseen.
- 8.5.2. Use a knife or razor scraper to cut away thick portions of sealant beads on surfaces and in joints, leaving a 1/16 inch of sealant on the substrate surface. Do not cut through depth of sealant. Do not contact knife with substrate.
- 8.5.3. Use a plastic scraper or wooded pallet to scrape paint form substrate to remove sealant.
- 8.5.4. Use a damp cotton rag to scrub the surface to remove remnants of sealant.
- 8.5.5. Wipe area where sealant was present with cotton rag soaked in denatured alcohol.
- 8.5.6. Remove excess and migrating joint sealing compounds, dirt, and foreign substances. Repair damaged areas of factory-applied finishes to match existing.
- 8.5.7. Sealant Application: Apply sealant in uniform continuous bead without gaps or air pockets, following manufacturer's instructions for type of sealant. Provide uniform cross-sectional shapes and depths relative to joint widths which allow optimum sealant movement capability.
- 8.5.8. Sealant Tooling: Immediately after sealant application and prior to time skinning or curing begins, tool sealants to form smooth, uniform to eliminate air pockets and ensure contact and adhesion of sealant with sides of joint. Remove excess sealant from surfaces adjacent to joint.

8.6. PAINTING MAINTENANCE

- 8.6.1. The painting shall have a like new smoothness and constancy of surface smooth texture. Apply paint in accordance with manufacturer's directions. Use applicators and techniques best suited for substrate and type of material being applied.
- 8.6.2. Provide finish coats which are compatible with prime paints used:
- 8.6.3. Apply a two-coat application with overnight drying between coats to minimize pinholes. Apply additional coats when undercoats, stains, or other conditions show through final coat of paint, until paint film is of uniform finish, color, and appearance. Give special attention to ensure that surfaces, including edges, corners, crevices, welds, and exposed fasteners, receive a dry film thickness equivalent to that of flat surfaces.
- 8.6.4. Scheduling Painting:
- 8.6.5. Apply primer coat material to surfaces that have been cleaned, pretreated or otherwise prepared for painting as soon as practicable after preparation and before subsequent surface deterioration.
- 8.6.6. Apply undercoat sealer and filler paint to conceal localized hairline cracks after primer inspection. Apply finish coat as final surface.
- 8.6.7. Allow sufficient time between successive coats to permit proper drying.
- 8.6.8. Do not recoat until paint has dried to where it feels firms, does not deform or feel sticky under moderate thumb pressure, and application of another coat of paint does not cause lifting or loss of adhesion of the undercoat.
- 8.6.9. Minimum Coating Thickness: Apply materials at not less than manufacturer's recommended spreading rate to establish total dry film thickness as indicated:
 - 8.6.9.1. Primer: 8.0 mils (0.203 mm) wet, 3.2 mils (0.081 mm) dry.
 - 8.6.9.2. Finish: 4.0 mils (0.102 mm) wet, 1.2 mils (0.030 mm) dry.
 - 8.6.9.3. Completed Work: Match for color, texture, and coverage. Remove, refinish, or repaint work not in compliance with specified requirements.

8.7. CLEANING and ADJUSTING

- 8.7.1. After completing maintenance and repairs, clean spattered surfaces. Remove spattered plaster or paint by washing, scraping, or other methods. Do not scratch or damage adjacent finished surfaces.
- 8.7.2. During progress of work, remove discarded materials, rubbish, cans, and rags from site at end of each workday. Thoroughly mixed and cured products may be disposed of in standard landfills. Uncured products are

- considered a hazardous material and must be handled as such and disposed in accordance with local regulations.
- 8.7.3. Correct any damage by cleaning, repairing or replacing, as acceptable to the Embassy

8.7.4.

8.8. AFTER IMPLEMENTATION

8.8.1. Provide 1-year installation warranty.

9. SAFETY

- 9.1. Contractor must submit with the bid, a Company Safety Plan including a specific Safety Plan tailored to this project to include an Activity Hazard Analysis (AHA).
- 9.2. All safety plans must conform to USACE (Army Corps of Engineers) Safety and Health Manual EM-385.
- 9.3. General. The contractor shall provide and maintain work environments and procedures which will safeguard the public and Government personnel, property, materials, supplies, and equipment exposed to contractor operations and activities; avoid interruptions of Government operations and delays in project completion dates; and, control costs in the performance of this contract. For these purposes, the contractor shall:
 - 9.3.1. Provide appropriate safety barricades, signs and signal lights;
 - 9.3.2. Comply with the standards issued by any local government authority having jurisdiction over occupational health and safety issues; and,
 - 9.3.3. Ensure that any additional measures the contracting officer determines to be reasonably necessary for this purpose are taken.
- 9.4.Records. The contractor shall maintain an accurate record of exposure data on all accidents incident to work performed under this contract resulting in death, traumatic injury, occupational disease, or damage to or theft of property, materials, supplies, or equipment. The contractor shall report this data in the manner prescribed by the contracting officer.
- 9.5. Subcontracts. The contractor shall be responsible for its subcontractors' compliance with this clause.
- 9.6. Written program. Before commencing work, the contractor shall:

- 9.6.1. Submit a written plan to the contracting officer for implementing this clause. The plan shall include specific management or technical procedures for effectively controlling hazards associated with the project; and,
- 9.6.2. Meet with the contracting officer to discuss and develop a mutual understanding relative to administration of the overall safety program.
- 9.7. Notification. The contracting officer shall notify the contractor of any non-compliance with these requirements and the corrective actions required. This notice, when delivered to the contractor or the contractor's representative on site, shall be deemed sufficient notice of the non-compliance and corrective action required. After receiving the notice, the contractor shall immediately take corrective action. If the contractor fails or refuses to promptly take corrective action, the contracting officer may issue an order suspending all or part of the work until satisfactory corrective action has been taken. The contractor shall not be entitled to any equitable adjustment of the contract price or extension of the performance schedule on any suspension of work order issued under this clause.

10. PROJECT SECURITY:

- 10.1. A list of employees who will work on this project, to include names (as shown on ID), and ID number must be submitted to COR within one (1) week of the Notice to Proceed (NTP).
- 10.2. Information on any vehicles which must come onto the Embassy Compound as part of this work must be submitted to the COR. This information is to include VIN number, license plate number, vehicle description, and color and must be submitted to the COR within one (1) week of the NTP.
- 10.3. Access to Site: all contractor employees and vehicles on the approved access list shall have escorted access to the Embassy work area ground.
- 10.4.
- 10.5. Material loading/off-loading shall be on the lay-down location specified by the COR.

11. GENERAL REQUIREMENTS

- 11.1. Shipping
 - 11.1.1. Material shipped into Djibouti for this project may be brought in duty free.
 - 11.1.2. The Contractor must pay for transportation of all Contractor purchased material to the site and the U.S. Embassy may provide tax exoneration certificate for customs.
 - 11.1.3. Packaging and Marking

- 11.1.4. Contractor will provide airway and shipping bills to the U.S. Embassy Procurement and Shipping Offices for exoneration of duty on material used on this project.
- 11.1.5. All costs associated with shipping, transportation to the Embassy, and movement through customs is the responsibility of this contractor.
- 11.2. Tools
 - 11.2.1. All tools and project machineries must be provided by the contractor.
 - 11.2.2. All tools must be taken off-site every day or stored in a container at the end of the workday.
 - 11.2.3. All machineries must be parked in designated area at the end of the workday.
 - 11.2.4. Trade Licenses
 - 11.2.4.1. All professional tradesmen licenses for Contractor personnel shall be current and valid at the time of COR review and shall be maintained and remain current and valid for the complete duration of the project execution.

12. NOTICE TO PROCEED

13. QUALITY ASSURANCE PLAN (QAP)

D. INSPECTION AND ACCEPTANCE

The COR, or his/her authorized representatives, will inspect from time to time the services being performed and the supplies furnished to determine whether work is being performed in a satisfactory manner, and that all supplies are of acceptable quality and standards.

The Contractor shall be responsible for any countermeasures or corrective action, within the scope of this contract, which may be required by the Contracting Officer as a result of such inspection.

D.1 <u>SUBSTANTIAL COMPLETION</u>

- (a) "Substantial Completion" means the stage in the progress of the work as determined and certified by the Contracting Officer in writing to the Contractor, on which the work (or a portion designated by the Government) is sufficiently complete and satisfactory. Substantial completion means that the property may be occupied or used for the purpose for which it is intended, and only minor items such as touch-up, adjustments, and minor replacements or installations remain to be completed or corrected which:
